FOR 2021-2022 TAX YEAR**

Who qualifies for a Senior Citizen exemption from Measure H?

To qualify for the Senior Citizen exemption, you must: (1) be 65 years of age or older on or before May 1, 2021; and, 2) own and occupy your property as your primary residence.

Where can I get a copy of the Senior Citizen Exemption Application?

Applications are available electronically, in person, or by request:

3. By request: Please call the Parcel Tax Administrator at (844) 332-0549 for an application by mail.

What information do I need to submit to obtain a Senior Citizen exemption?

You will need to provide the following documents:

1. A completed Senior Citizen Exemption Application.
2. A current (most recent) tax bill from the Contra Costa County Tax Collector showing ownership.
3. Proof of age (one of these):
 - a. Driver's License or Department of Motor Vehicles Identification Card
 - b. Birth Certificate
 - c. Passport

Where do I send the application form and required documents?

Please mail the application form with photocopies of your property tax bill and proof of age to the **Walnut Creek SD Exemption, 4745 Mangels Blvd, Fairfield, CA 94534.**

Is there a deadline to submit the Senior Citizen Exemption Application?

In order to notify the County of the exemption in time for the 2021-2022 tax bill, we must receive your application no later than **May 1, 2021.**

I received the exemption on my last property tax bill. Do I need to reapply?

Once you receive the senior citizen exemption for Measure H parcel tax and continue to own and reside at the same address, you **do not** need to renew your tax exemption each year, it will automatically be renewed.

If you sell your home and purchase a new home, you must re-file for the senior citizen exemption for the new property.

___ Property tax bill (Property Tax Bill must accompany form)

In order to determine eligibility, we may request additional documentation.

Once approved for the exemption, the exemption will be automatically be renewed annually as long as the applicant continues to own and occupy the property as the main residence. If you sell your home and purchase a new home, you must re-apply for a Senior Citizen Exemption for the new property.
